### COVID-19

Governor Whitmer issued an executive order directing all Michigan businesses and operations to temporarily suspend in-person operations that are not necessary to sustain or protect lives. Businesses and operations are prohibited from requiring workers to leave their homes, unless those workers are necessary to sustain or protect life or to conduct minimum basic operations. However, carryout, curbside services and delivery from restaurants are still available.

Due to the COVID-19 outbreak, the **Plymouth Community United Way** has started a COVID-19 Relief Fund to support those in Plymouth, Canton and Western Wayne County who are negatively impacted by the virus.
